

STEP 1 - Preparation

DO NOT REMOVE THE LIGHT BLOCKER UNTIL STEP 4

Open the top cover of your tank. Inspect the tank dial and confirm that it is a Remote Ready Dial, as shown in *Figure A* below. If you do not have a Remote Ready Dial, please contact us at support@centriconnect.com

The Centri Tank Monitor will not operate correctly without a Remote Ready Dial.

Once the Remote Ready Dial is installed, remove the plastic "Remote Ready" tab as shown in *Figure B* below. Some dials may have the tab already removed.

Continue to Step 2.

STEP 2 – Sensor Connection

DO NOT REMOVE THE LIGHT BLOCKER UNTIL STEP 4

Next, connect the sensor to the Remote Ready Dial, as shown in Figure C below.

Continue to Step 3.

IMPORTANT NOTICE: THE SENSOR MUST BE INSERTED INTO THE REMOTE READY DIAL SLOT IN THE DIRECTION SHOWN IN FIGURE C. FAILURE TO FOLLOW THIS INSTRUCTION PRECISELY MAY RESULT IN DAMAGE TO THE SENSOR AND MAY VOID YOUR WARRANTY.






Figure E DO NOT INSTALL THE SENSOR VERTICALLY


STEP 3 - Mount Tank Monitor

Option 1: Fuel Tanks

DO NOT REMOVE THE LIGHT BLOCKER UNTIL STEP 4

Next, inspect your fuel tank and identify a location for mounting the Centri Tank Monitor. To maximize exposure to the sun, the Centri Tank Monitor must be installed on the most sunlit part of the tank with the Solar Cell pointing towards the sun. If you are unsure, place the tank monitor on the south facing part of the tank. Ensure that the installation surface is clear and free from debris, such as snow, dirt, dust, sand, etc. Use the magnetic mounts on the bottom of the tank monitor to mount. Additionally, ensure that the sensor cable is not pinched, squeezed, or compressed by the tank cover.

IMPORTANT NOTICE: DAMAGING THE CABLE MAY RESULT IN IMPROPER FUNCTIONALITY AND MAY VOID YOUR WARRANTY.

STEP 3 – Mount Tank Monitor

Option 2: Above Ground Propane Tanks

DO NOT REMOVE THE LIGHT BLOCKER UNTIL STEP 4

Next, inspect your propane tank and identify a location for mounting the Centri Tank Monitor. To maximize exposure to the sun, the Centri Tank Monitor must be installed on the most sunlit part of the propane tank with the Solar Cell pointing towards the sun. If you are unsure, place the tank monitor on the south facing part of the tank. Ensure that the installation surface is clear and free from debris, such as snow, dirt, dust, sand, etc. Use the magnetic mounts on the bottom of the tank monitor to mount. Additionally, ensure that the sensor cable is not pinched, squeezed, or compressed by the tank cover.

IMPORTANT NOTICE: DAMAGING THE CABLE MAY RESULT IN IMPROPER FUNCTIONALITY AND MAY VOID YOUR WARRANTY.

Continue to Step 4. Tank monitor installed on the most sunlit or south facing portion of the tank. Sensor cable free from obstructions, pinching, squeezing, or compression.


STEP 3 – Mount Tank Monitor

Option 3: Under Ground Propane Tanks

DO NOT REMOVE THE LIGHT BLOCKER UNTIL STEP 4

Next, inspect your underground tank hatch cover and identify a location for mounting the Centri Tank Monitor. To maximize exposure to the sun, the Centri Tank Monitor must be installed on the top hatch cover with the Solar Cell facing upwards. Ensure that the installation surface is clear and free from debris, such as snow, dirt, dust, sand, etc. When using the recommended secure mounting methods listed below, only the auxiliary mounting holes on the enclosure must be used. Do not modify, puncture, cut, or drill into the Centri Tank Monitor's enclosure. Additionally, ensure that the sensor cable is not pinched, squeezed, or compressed by the tank cover.

IMPORTANT NOTICE: MODIFYING THE CENTRI TANK MONITOR'S ENCLOSURE WILL VOID THE WARRANTY. ADDITIONALLY, DAMAGING THE CABLE MAY RESULT IN IMPROPER FUNCTIONALITY AND MAY VOID YOUR WARRANTY.




STEP 4 – Activation

Remove the light blocker and direct sunlight to the Solar Cell to activate the Centri Tank Monitor, per *Figure H* below.

If you are installing the Centri Tank Monitor in the dark, you may need to use a light source, such as a flashlight, to activate the device.

Once activated, the Status LED will start blinking yellow. This means that the device is activating and connecting to the cellular network. This may take up to 10 minutes to complete. You can connect to your device on the CentriConnect app during the cellular connectivity process (Step 5).

Once connected to the cellular network, the Status LED will start blinking green. This means that the device has successfully connected to the cellular network and has completed its activation cycle. After 30 minutes, the Status LED will cease to blink green. If the Status LED starts blinking red, please contact us at support@centriconnect.com.



STEP 5 – Connecting Your Device

Download the **CentriConnect App** on the Google Play Store or the Apple App Store.



Create an account.

Once logged in, select "Add Monitor", and follow the steps on the **CentriConnect App** to connect to your Centri Tank Monitor.

The QR Code of the **Device ID** can be found on the bottom of the device, as shown in *Figure I below*, or on the device activation card which was delivered with the product.

The device authentication code can be found on the device activation card delivered with the product. If you lose your device activation card or your device authentication code, please contact support@centriconnect.com and send your **Device ID** along with a picture of your device's QR code label.
